The Board drafted rules consistent with other professions governed by the board. This rule was structured in a manner consistent with other physician rules and in compliance with the provisions of 334.036, RSMo. This language mirrors that of APRN collaborative practice agreements, including the mileage, telehealth, and review requirements.

Please explain how your agency has involved small businesses in the development of the proposed rule.

Since the passage of SB716, the Board's website has included information about assistant physician laws and provides the public with rule updates.
