The Missouri Veterinary Medical Board is proposing a new regulation in order for the board to accept evidence of military education, training, or service to be applied toward the requirements for licensure.

Pursuant to section 324.007, RSMo, which was enacted in 2013, every professional licensing board shall establish by rule the criteria to accept evidence of military education, training, or service to be applied toward the requirements for licensure.

This proposed rule is necessary to implement that statute. It provides for the board to accept evidence of military education, training, or service to be applied toward the requirements for licensure.

Please explain how your agency has involved small businesses in the development of the proposed rule.

The board discussed this proposed regulation at the January and April 2014 open board meetings. All members of the board participated in the discussion.

The board publicly posts its meetings on the board's website and with the Office of Administration. The board also distributes copies of the agenda and/or proposed rule upon request.

After the proposed rule is filed with the Secretary of State's Office, a public notice for this rulemaking will be published in the *Missouri Register* and posted on the board's website. Any comments received prior to the close of the public comment period will be considered and addressed prior to filing the final order of rulemaking.

The proposed rule will cost our agency approximately three dollars (\$3) annually in postage costs.

This rule will allow applicants with the appropriate military experience, the ability to submit evidence of military experience as a part of the requisite education and/or training requirements for licensure.

The proposed rule will allow applicants, for licensure, to submit military education, training, or service as evidence to be applied toward the requirements for licensure. There will be the incurred cost of one dollar and five cents (\$1.05) for postage and copy cost for the applicant, when mailing their evidence to the board office.
